Special Regulations for Sales

1. No camping will be allowed in Chandler Park. Volunteer as well as paid security will be provided. Exhibitors are permitted to pull into the park near their assigned area to unload crafts/displays. **You must immediately move your vehicle to a designated parking area before setting up your exhibit.**

Exhibitor will not hold the City of Macomb, Macomb Heritage Days, or any of its committee members responsible for accidents, damage or loss to the exhibitor or family members during the 2007 Macomb Heritage Days Craft Show, and will release them from any liability.
